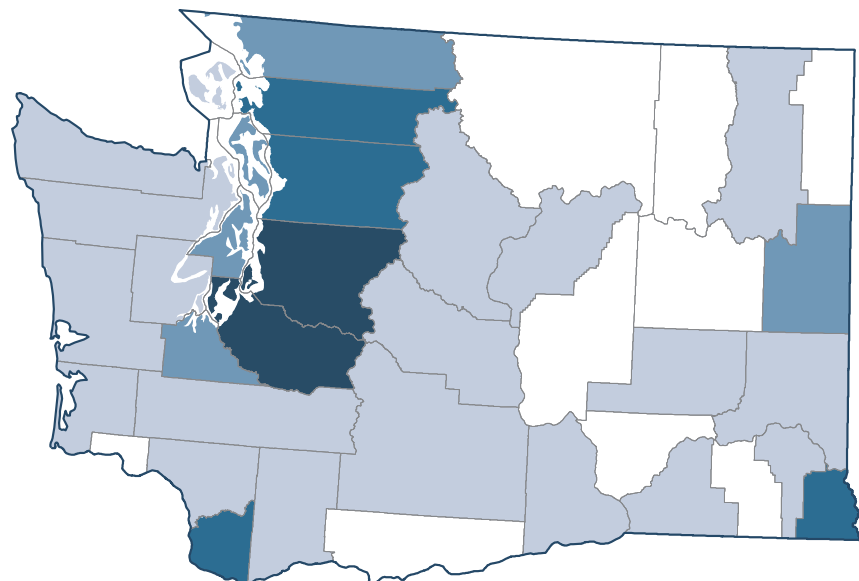
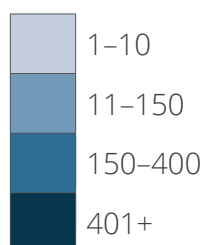
Economic Output

Output represents the total value of all sales and other operating income occurring in Washington, including taxes, supply chain purchases, and compensation of employees. After accounting for supply chain and consumption effects, Regence and its parent and affiliated companies supported **\$377.9 million in total gross economic activity** in 2016.

Workforce

Regence and its parent and affiliated companies provided **2,236 family wage jobs** across Washington, paying **\$126.6 million in labor income**. Each job provided by the companies supported 1.4 additional jobs in the state.

Spending

Operations spending by Regence and its parent and affiliated companies in Washington amounted to **\$221.6 million** in 2016 (including taxes). Approximately 77 percent of total operations expenditures—about \$170.6 million—were spent in Washington.

Multiplier Effect in Washington

Output Multiplier: 1.6

Every million dollars spent by Regence and its parent and affiliated companies supports another **\$600,000** in spending across Washington.

Income Multiplier: 1.3

Every million dollars of income paid to employees of Regence and its parent and affiliated companies supports **\$300,000** of income for workers in other sectors of the economy.

Job Multiplier: 1.4

Every 10 direct jobs at Regence and its parent and affiliated companies are linked to another **4 jobs** elsewhere in Washington, for a total of 3,162 positions.

Charitable Contributions

Regence and its parent and affiliated companies and employees, along with its philanthropic foundation, gave \$3.6 million to 484 local non-profits and charities in Washington during 2016. Beyond direct expenditures, 462 Regence employees provided 1,798 hours of volunteer service.
